## Conditions

In order to be eligible for the Sollio Next Generation Award the applicant must:

- Be a member and client of a cooperative in the Sollio Cooperative Group's network;
- Be less than 40 years old in the year of participation;
- Own at least 20 % of the shares of the farm, for a maximum of 10 years before participating in the contest.

## **Process Overview**

## Step 1: Online submission form

- Applicants must thoroughly complete the online submission form.
- Information provided will be reviewed and used for evaluating purposes for the judging panel.
  - o It is recommended that the application be proofread by someone from the cooperative supporting the nomination.
  - o All information will be taken into account in the jury's evaluation. It is important to complete each section in as much detail as possible.
- The farm succession members must be recommended by a cooperative from Sollio's network and provide a signed letter of recommendation from the cooperative's President.
- The letter must include the reasons why the farm should win the contest, and the quality of the responses provided will be taken into account by the judging panel. The judging panel will review the written documents submitted by the candidates. Note that the members of the judging panel will sign a confidentiality agreement before reviewing candidates' files.
- The application process must be completed by May 1<sup>st</sup>, 2023.

## Step 2: Semi-Finalists

- After confidentially reviewing all online submission form entries, the panel of judges will select semi-finalists.
- The semi-finalists will be contacted to coordinate a time to have the judging panel visit their farm for an in-person interview and tour.

## **Step 3: Finalists and Winners**

- Once the judging panel visit all semi-finalist farms, applicants will be contacted and informed if they are a finalist or not.
- Finalists will be visited by a reporter and a videographer for the production of a short video.
- Finalists will be featured in the Coopérateur magazine, published by Sollio Cooperative Group. Winners will be featured in an advertorial published in a regional leading agricultural magazine.
- Finalists will be invited to attend the awards ceremony at the Annual general meeting of Sollio Cooperative Group, where the winners will be formally announced.
